Ledelsesberetning

Menighedens aktiviteter.

Menighedens hovedaktivitet er at drive kirke i København.

Økonomisk udvikling.

Trods den globale Covid-19 pandemi har vores økonomi været sund og regnskabet i 2021 har været positiv. Vores indtægter var lidt over forventning mens vores udgifter var væsentlig under forventning pga. delvis nedsættelse af timer i en af præsternes ansættelse for en periode. Feriemidlerne som var hensat i 2020 er blevet overført til feriefonden i dette finansår og vores passiver er blevet nedskrevet med udskudt AM-bidrag samt A-skat. Det er ledelses vurdering, at kirken forsat har en sund økonomi.

Der er ikke sket andre væsentlige ændringer i menighedens økonomiske forhold.

Anvendt regnskabspraksis

Årsrapporten er aflagt i overensstemmelse med årsregnskabslovens bestemmelser for Regnskabsklasse A.

Generelt om indregning og måling

I resultatopgørelsen indregnes indtægter i takt med, at de indtjenes, herunder indregnes værdiregulering af finansielle aktiver og forpligtelser. I resultatopgørelsen indregnes ligeledes alle omkostninger, herunder afskrivninger og nedskrivninger.

Aktiver indregnes i balancen, når det er sandsynligt, at fremtidige økonomiske fordele vil tilflyde menigheden, og aktivets værdi kan måles pålideligt.

Forpligtelser indregnes i balancen, når det er sandsynligt, at fremtidige økonomiske fordele vil fragå menigheden, og forpligtelsens værdi kan måles pålideligt.

Ved første indregning måles aktiver og forpligtelser til kostpris. Efterfølgende måles aktiver og forpligtelser som beskrevet for hver enkelt regnskabspost nedenfor.

Visse finansielle aktiver og forpligtelser måles til amortiseret kostpris, hvorved der indregnes en konstant effektiv rente over løbetiden. Amortiseret kostpris opgøres som oprindeligt kostpris med fradrag af eventuelle afdrag samt tillæg/fradrag af den akkumulerede amortisering af forskellen mellem kostpris og nominelt beløb.

Ved indregning og måling tages hensyn til forudsigelige tab og risici, der fremkommer inden årsrapporten aflægges, og som be- eller afkræfter forhold, der eksisterede på balancedagen.

Alle beløb i regnskabet er opgjort i DKK.

Resultatopgørelsen

Menighedsbidrag m.v.

Menighedsbidrag omfatter bidrag fra medlemmer, gaver, arv og andre bidrag der er ydet til menigheden.

Omkostninger til menighedsdrift omfatter omkostninger til gudstjenester, møder, udvalg, reklame, administration, lokaler, drift af ejendomme, gevinst/tab på salg af driftsmidler m.v.

Personaleomkostninger

Personaleomkostninger omfatter løn og gager, inkl. feriepenge og pensioner, samt andre omkostninger til social sikring mv af menighedens medarbejder. I personaleomkostninger er fratrukket modtagne godtgørelser fra offentlige myndigheder.

Finansielle poster

Finansielle poster indtægter og omkostninger indregnes i resultatopgørelsen med de beløb der vedrører regnskabsåret. Finansielle poster omfatter renteindtægter og -omkostninger, realiserede og ikke-realiserede kursgevinster.

Nedskrivninger opgøres som forskellen mellem den regnskabsmæssige værdi af tilgodehavender og nutidsværdien af de forventede pengestrømme, herunder realisationsværdi af eventuelle modtagne sikkerhedsstillelser. Som diskonterings-sats anvendes den effektive rente for det enkelte tilgodehavende.

Periodeafgrænsningsposter

Periodeafgrænsningsposter, indregnet under aktiver, omfatter afholdte omkostninger vedrørende efterfølgende regnskabsår.

Gældsforpligtelser
