#### **PREAMBLE**

With the purpose of establishing and maintaining a place for worship of the Almighty God and for the communion of those who profess the same faith, where there is the preaching of the Gospel of our Lord and Savior Jesus Christ, conversion of lives, teaching and training of believers for Christian service, we, the signatories of this Statute, constitute ourselves as church, a non-profit, religious, social, educational and cultural entity.

#### **ARTICLE 1 - DENOMINATION**

This Church is called BETHLEHEM MINISTRY OF THE ASSEMBLIES OF GOD; its field of work comprises the cities where, under the guidance of the Central Ministry in Lighthouse point, FL, USA, maintain or come to start new Churches in any language or culture.

#### **ARTICLE 2 - STATEMENT OF FAITH**

This Church accepts the Bible as the revealed will of God, the sufficient and unlimited rule for faith and practice and for the purpose of maintaining general unity, adopted by the Statement of Fundamental Truths, approved by the CGADB – General Convention of the Assemblies of God in Brazil and The General Council of the Assemblies of God in the United States of America.

#### ARTICLE 3 – THE ORDINANCES OF THE CHURCH

Section 1 - The ordinance of baptism in the waters, by immersion, according to Matthew 28:19, shall be administered to all those who have repented of their sins and believe in the Lord Jesus Christ for the salvation of their souls and who have been born again clearly evidencing such experience and have participated in teachings on the Fundamental Truths and the bylaws of our Church. Col. 2.12 and II Tes. 3.6.

Section 2 – The ordinance of the Lord's Holy Supper shall be monthly observed, according to the scriptures – Luc. 22.19,20 and I Cor. 11.23-24. The participation of the Holy Supper shall be for members baptized in water according to scripture, by immersion, in the name of the Father and the Son and the Holy Spirit. Mat. 3.13-17 and Mat. 28.19, and in accordance with this article.

#### **ARTICLE 4 - MEMBERSHIP**

Section 1 – This assembly reserves, through its board of directors, the right to accept the request for a member, from those who voluntarily requests it, once evidenced the proof of his faith and testimony of the Lord Jesus Christ, expressing his willingness to obey the doctrines, statutes, bylaws, norms, and resolutions adopted by the Church. The signature of the Term of Commitment at a regular public service at the church will consecrate the appropriate acceptance at the role of members of the church with the given ad referendum of the assembly.

<u>Section 2</u> – Members in communion shall contribute with their offerings and will tribute their tithes to the Lord God, which are intended for the maintenance of workers, formation and expansion of the Church's social patrimony, and other purposes provided for in this Bylaws.

Section 2 - All Church properties shall hold deed under its name and none of its actual properties may be sold, rented, mortgaged or subject to any type of transaction without it having been authorized by the Superintendent Pastor and Board of Directors, ratified by the General Assembly. 1. 4, Section 3 - In the event of dissolution of the Church, after fulfilling all its commitments and responsibilities, the remainder assets will be destined to another society etc. which is domiciled in Denmark or in another EU/EEA member state and has a charitable or 1 8 otherwise non-profit object. Section 4. In the event of a deviation or transgression of the Rules of Faith adopted by the Church in accordance with the terms of the General Council of Assemblies of God and/or Bethlehem Ministry in Brazil, to the faithful members of such principles, whatever the number remaining in the Church, shall be given the possession and administration of documents and all assets of the Church. 1 1 **ARTICLE 12 - MEMBERS' RIGHTS** Any member in perfect communion with the church, who keeps its obligations and responsibilities to the Church, have the right to: 1. Participate in the Ordinary, Extraordinary General Assemblies. . 2. Vote for the choice of board members. 3. Be appointed to compete for a position always and when your name has been indicated on the grounds of its ability and reputation. 4. To know about the application of the Church's financial resources. 1. 4 **ARTICLE 13 - PENALTIES** Section 1 - The penalties to which the members are subject are: 1 8 1. Warning 2. Suspension of communion and positions 3. Dismissal. Section 2 - Members who depart from the obedience to biblical principles, ordinances and .4.1 other rules required by the Church, including the Articles of faith mentioned in Art. 11, Section4, shall be subject to disciplinary measures. Section 3 - On the event of an accusation against any member of the church, it shall be addressed to the Local Pastor or another member of the Ministry. There shall be a proper investigation by 1.1 the Pastor himself or by a special committee appointed by the same and/or Ministry when applicable. Section 4 - The member of the Ministry, or the Board of Directors, or leading a local church, or 1 % in any other position of leadership or not shall be immediately removed from his office in the event of suspension of communion or dismissal of the Church. Section 5 - The President Pastor and the Board of Directors will be authorized to review annually the list of members to revalidate or not the appropriate credentials soon after the verification of attendance to the services. **ARTICLE 14 - CONGREGATIONS AND LOCAL PASTORS** 1 1 Section 1 - Congregations are administered by the President Pastor through their Local Pastors.

Section 2. The position of the Local Pastor of the Congregation shall be held as a position of trust and may be replaced at any time in accordance with the provisions of Art. VI, Section 4.

#### **ARTICLE 15 - QUORUM**

The quorum for decisions at any meeting may not be less than one third (one third) of the members of the Church, subject to the provisions found in these bylaws.

#### **ARTICLE 16 - AMENDMENTS**

This bylaws may be amended at the General Assembly by a vote of 2/3 (two-thirds) of the members since the amendment proposal has been called and approved by the Superintendent Pastor, also approved by the General Ministry (head office – USA) and the local board of directors, and a copy of the draft project stayed in the Office of the Church for the acknowledgement of members of the Church for at least fifteen days before the meeting specific called for this purpose.

#### **ARTICLE 17 - OMITTED**

The omitted cases in this Bylaws will be resolved by the Superintendent Pastor and/or Ministry and General Assembly depending on their importance or severity.
